**A Supreme Bench Judge Should Have a COMPREHENSIVE LEGAL EDUCATION.**

1. **JOE HOWARD** graduated from the University of Iowa with a Bachelor of Science degree.
2. **JOE HOWARD** graduated in the upper quarter of his class from the University of Washington Law School in 1954.
3. **JOE HOWARD** received a Master's degree in the field of legal philosophy from Drake University in 1955.
4. **JOE HOWARD** finished a special prosecutor's course at Northwestern University Law School in 1966.

**A Supreme Bench Judge Should Have EXTENSIVE COURTROOM TRIAL EXPERIENCE.**

1. **JOE HOWARD** served as a practising lawyer with the Howard & Hargrove firm from 1960-1964, and is now a partner in that firm.
2. **JOE HOWARD** was an Assistant State's Attorney from 1964-1968; he served as Chief of the Trial Section of that office from 1966-1968; during which time he trained all new prosecutors in trial work.
3. **JOE HOWARD** served as an Assistant City Solicitor in 1968.
4. **JOE HOWARD** has tried over FOUR THOUSAND CASES as a defense attorney and as a prosecutor; these cases range from complex death penalty crimes to simple disorderly conduct offenses.
5. **JOE HOWARD** was a defense lawyer in the U.S. Army from 1943-1948.

**A Supreme Bench Judge Should Be a LEGAL SCHOLAR**

1. **JOE HOWARD** is the author of a 522-page dissertation entitled "An Inquiry into the Application of the Sociology of Knowledge to the Field of Law."
2. **JOE HOWARD** researched and wrote a much-publicized study entitled "Administration of Rape Cases in the City of Baltimore and the State of Maryland."
3. **JOE HOWARD** as Chairman of the Mayor's Task Force on Juvenile Delinquency is now directing a comprehensive study into the problem of youth crime in Baltimore.

**A Supreme Bench Judge Should Understand the Social Problems Involved in the Administration of Justice.**

1. **JOE HOWARD** served as a social caseworker in Des Moines, Iowa and a probation officer in Baltimore City. (1958-1960).
2. **JOE HOWARD** served as a special consultant to the Department of Education's Division of Community Schools in 1967.
