#### CALL TO ORDER

### MARYLAND STATE DEPARTMENT OF EDUCATION REPORT

Walter Sallee, Director of Student Services and Strategic Planning, Maryland State Department of Education and Commission member, provided a PowerPoint briefing. Specifically, he presented an overview of student discipline in Maryland, an update on school arrest data, the Maryland guidelines for a state code of discipline, and the local codes of discipline. Mr. Sallee reported he did not have accurate and consistent school arrest data from the local education agencies (LEA's) as there were data collection issues. A number of LEA's must revise their reported data so outside arrests are not counted in school-based arrests and referrals to law enforcement. MSDE is now directing school superintendents to review and revise data if needed. He plans to report this refined data in the future, possibly at the next Commission meeting in November.

A number of Commission members and attendees asked questions of Mr. Sallee around the statewide data which he answered.

## **NEW BUSINESS**

Chairperson Grochal shared a slide with several suggestions for future meetings, which included tapping internal expertise of Commission members as well as national experts. She then opened the floor for comments about the Commission's next steps.

She then asked members to complete an input form as a means of gathering specifics regarding what information they are seeking, suggestions for presenters, and interest in participating in the Planning Sub-Committee.
