# Dispute Resolution Track Course Offerings (for summer 2023-spring 2024)

Students should always check the course catalog for the most up to date offerings and cancellations

The Dispute Resolution Track requires a minimum of 15 credits from (1) a pre-approved list of dispute resolution courses and (2) an experiential requirement. At least 9 of the 15 credits must be from the pre-approved dispute resolution courses. Students must notify the managing director of their intent to graduate with the Dispute Resolution Track at least one semester before their final semester of law school.

This updated course offering document represents updates to the Dispute Resolution Track requirements effective summer 2023. Students graduating in summer 2023, fall 2023, or spring 2024 must talk with Lisa Mebane to review their requirements and status.

**Externships:** Students may complete an ADR externship in which the student gains extensive conflict resolution experience. ADR externships are subject to the approval of the Dispute Resolution Program managing director. Externships must be three or more credits, plus the one-credit ADR Externship Workshop. All externships must satisfy the law school's general externship requirements. A full list of previously approved ADR externships is available online.

**Fellowships**: Students may request approval of a Fellowship experience to fulfill the experiential component (and some credits toward the DR Track). Approval will be based upon similar criteria to that of the ADR externship. The Jablow Mediation Fellowship fulfills the Dispute Resolution Track experiential requirement
